# In Perspective



Maybe you've heard of the Ombudsman program, but you're wondering what exactly they do, or more importantly how can they help me? Regardless of age, if you or someone you know lives in long-term care, the answer is yes! We can help! We're here for you.

Ombudsmen advocate for people living in long-term care, as well as people who are receiving temporary care which requires a short-term stay. For example,

maybe you are a person who has lived in a nursing home for many years, or perhaps you are someone who was discharged from the hospital after a broken hip and just need short-term care for rehabilitation before going back home. Either way, Ombudsmen are authorized through the Older Americans Act to be an advocate for you.

Ombudsmen are not affiliated with long-term care facilities. The Ombudsman program is provided through Missoula Aging Services, in our mission to support the independence, dignity and health of older adults and those who care for them.

Residents living in long-term care are the cornerstone of the Ombudsman program, and we are committed to protecting their Residents' Rights. We welcome referrals, which remain confidential. Once a referral is received, our investigation begins with the resident. The resident is our client, regardless of the source of the complaint. The resident's dignity and self-determination are our highest priority. Ombudsmen honor the resident's wishes over any other individual or organization.

Why are Residents' Rights so important? People living in long-term care retain their civil rights, and residents are granted additional rights called Residents' Rights which are protected by law. Long-term care facilities must actively promote and protect all these rights. Residents' Rights have a significant impact! When residents are fully informed, treated with dignity and respect, given the right to make their own choices and communicate freely with people inside and outside of the facility, it greatly enhances their quality of life and quality of care. Residents' Rights were created by Congress in recognition of the perception of the power imbalance between residents and staff, and the tendency for long-term care facilities to operate as an impersonal system which requires the residents to fit in.

Residents' Rights empower residents and recognize their right to choose aspects of their life that are important to them. For more information, call Missoula Aging Services at (406)728-7682.

# ABOUT THE LEVY **Protecting Seniors, Supporting Caregivers**

Missoula Aging Services (MAS) was established by Missoula County in 1982 to promote the independence, dignity and health of older adults, and those who care for them. MAS has done much for our community over the past 40 years but is facing the challenge of keeping up with the growing needs of an increasingly older population.

In 2007, voters passed a \$350,000 levy for Missoula Aging Services that has remained flat for 15 years, with no adjustment for population growth or inflation. Meanwhile, the number of older adults in Missoula County grew 40% between 2010 and 2019, four times the rate of overall population growth. Currently, about 35% of Missoula County households include an older adult.

Repealing the flat levy and replacing it with the proposed 4-mill levy on the June 7th ballot will provide MAS with additional resources to keep pace with growing needs and sustain more than 20 critical programs that help older adults age safely at home and stay engaged in their communities.

### APPROVING THE LEVY WILL HELP **MISSOULA AGING SERVICES:**

- Sustain needed services that have outgrown available funding. The need for Meals on Wheels services has grown by two-thirds in the past two years, along with a rapid increase in the need for technology and other services that help older adults access health care and stay socially connected.
- Protect and advocate for older adults in nursing homes. MAS staff make thousands of visits to residents each year.
- Prevents exploitation and abuse. MAS helps older adults manage their money and avoid scams.
- Help older people find and afford caregivers.

MAS is a lifeline for older adults needing support, including those with Alzheimer's and related dementias, and their families.

- Help older adults stay in their homes and save taxpayers money. MAS provides numerous services that help older people stay in their homes and live independently, which is much less costly to taxpayers than a nursing home. Many clients are able to contribute to the cost of services, which enables MAS funding to go farther and help more people.
- Keep up with the needs of our increasing older population. By 2030, 22% of the population in Montana is projected to be over the age of 60.

### WHAT WILL IT COST?

The levy amounts to a modest increase of \$3.69 per year for each \$100,000 of a county home's taxable value, or about \$1.50 per month for the average homeowner in Missoula.

This is a sound investment to support our aging friends, family and neighbors and those who care for them.

Missoula Aging Services volunteer Tobie Weist has led a full life of selfless service. A retired University of Montana professor, Peace Corps alum and current volunteer with the American Red Cross, she has served everywhere from South Africa to South Korea and has also helped closer to home, including with the Red Cross in 2005 after Hurricane Katrina — an experience she will never forget.

She was 64 years old when she got her start with the Red Cross, assisting in a local shelter during the 2000 Bitterroot Valley wildfire, one of the largest fires in the nation at the time.

"The Red Cross spends a lot of effort on training its volunteers for shelter work," she said. "It is very easy to be a volunteer."

Now 85, she encourages others to lend their time to keeping themselves and their community safe during a disaster. She suggests you begin by preparing yourself in case of emergencies including home fires and wildfires.

This June, Missoula Aging Services and Montana Red Cross have teamed up to sponsor a free, one-hour virtual Be Red Cross Ready training with tips on how to keep you and your loved ones safe in case of a disaster. This includes tips like keeping an extra copy of your prescriptions in the glove compartment of your car in case of a house fire. # Montana SMP Warns of Latest Medicare Scam



- Help check for and correct billing errors.
- Provide education about managing Medicare bills and protecting yourself.

SMP is a national program managed in Montana by Renee Labrie-Shanks, the Statewide SMP Program Director, based out of Missoula Aging Services. If you know of someone who needs help understanding their health care bills, would like to report fraud, or are interested in learning more about our program, in Missoula contact Missoula Aging Services (406) 728-7682, or elsewhere in Montana call 1(800) 551-3191 for the SMP in your area.



In Montana, scammers are calling people on Medicare claiming they are replacing the paper Medicare cards with plastic ones that include chips. Medicare is not replacing or altering the paper cards in any way.

Medicare does not make unsolicited calls and will never call to sell anything. Do not give your personal information over the phone, simply hang up.

Montana Senior Medicare Patrol (SMP) is a statewide program that works to support and protect Medicare recipients from fraud and abuse. Through Montana SMP, volunteers help others become proactive consumers identifying potential mistakes, abuse or fraud in medical billing. Montana SMP will:

Help you understand and organize your medical bills and Medicare Summary Notices.

In cases of potential fraud, contact and refer to the appropriate agency to investigate the issue.
