Rooted in Community



Jim Cook built his life around a love of the outdoors and a career in forestry as a certified arborist. "I've been a tree-hugger my whole life," he says. He first came to Missoula as a 19-year-old smokejumper, and in 1975 founded Able Tree Service, caring for the city's trees and earning a reputation for expertise and integrity. For over 40 years, Jim has been known around Missoula as the "tree doctor," as passionate about educating clients as he was about caring for their trees. He still takes pride in a legacy now carried on by his daughter-in-law after his son's tragic death in a snow machine accident. Jim first connected with Missoula Aging Services when a client recommended the agency.

Now in his 80s, Jim lives alone in an affordable apartment with a view of the mountains. Jim's limited fixed income and daily life with dementia present challenges to his independence. With support from Missoula Aging Services, Jim remains active in the Missoula Senior Forum and other community groups.

After doctors advised him to stop driving, he began relying on his bicycle for short trips and on a **Caring Companion volunteer** for transportation to appointments, shopping, and social events. **In-home care management** provides guidance and reassurance as his needs evolve, while **Meals on Wheels** delivers both nutrition and a friendly check-in.

Together, these supports help Jim maintain dignity and safety-and remain rooted in the community he served for so long.


