Assisted Living Facilities

What is Assisted Living?

The Assisted Living allows individuals to live in a community setting with daily care and does not require skilled nursing and medical care such as physical therapy.

Assisted Living residents usually live in their own apartments or rooms and share common areas. Access to services include up to three meals a day; assistance with personal care, help with medications, housekeeping, and laundry; 24-hour supervision, and on-site staff, and social and recreational activities. Atmosphere, activities, and food varies from one facility to another. You may tour the facilities to find the right fit.

In Missoula County, Assisted Living Facilities range in size from as few as 4 residents to 120. Some offer "levels of care", with residents paying more for higher levels of care. Others offer a single rate for services.

Each provides different types of assisted living called category endorsements: A, B, or C based on the activities of daily living. Activities of daily living are tasks done in a typical day: bathing, eating, dressing, grooming, transferring, walking, managing medication and using the bathroom. When needing help with fewer than 3 activities of daily living, it is category A. For help with more than 4 activities of daily living, it is category B. For individuals who have a diagnosis of Alzheimer's or related dementias, where the individual is not capable of expressing needs or making care decisions, it is category C.

Who oversees Assisted Living Facilities?
